Ngol kongol hawtangol dho ko humitingol e golle fewndidhe fi moyyhintingol hawre wondude e ballal CAO, hakkunde toddhabhe 26 dieyabhe e kodholi 13 Sangarédi<sup>1</sup>, wondude e ballal modyobhe tati<sup>2</sup>, e La Compagnie des Bauxites de Guinée (CBG) (" tawabhebhen ka yewtere"). Wullitande nden addano e lewru Février hitande 2019, bhe dhidho non holli hibhe faala moyyhintinirgol yewtere sokholadyi holladhi ka nder wullitande. Tippude e kobhetori, SFI (Société Financière Internationale) e Halco (Mining) inc. (bhedho tato wadhubhe dyawle mun ka CBG) kobhe yhewobhe golle moyyhintingol hawre nden.

Tumbodire ka masin hoy dyego whadhama e nder o mediation hakkunde lewru Avril e octobre hitande 2021 fi yewtugol, faltondira e taskagol ebbhodye humitidhe e batte fettingol faya on ka kodholi, ko tobbhere aranere nde tawabhebhen ka yewtere subhi fuddhorgol ka golle moyyhintingol harenden.

Nyalande 21 octobre hitande 2021, Tawabhe bhen ka yewtere wadhuno batte dyungo **fottande humitinde e fettingol faya on**, e nder dhun bhe fottani ebbhodye humitinde e : a) moyyhintingol bonneredyi ( dhi expert dyo on wadhi tewtewre) dhi fettingol faya on wawata wonde sabu mun, b) hiwugol e dhuytugol batte golle arodye dhen, wondude e c) Tawnorgol e moyyhintingol batte golle arodyedhen, e modyintingol batte golle arodyedhen e immorde o fettingol faya on.

- CBG attay fettingol faya on e nder meter wulure(1000) e moggo hodho gila e go' o lewru octobre hitande 2021. E bhe gollitirta masindi dyasirdhi dhin e der meter temedhe diowi 500m moggo hodho ha tuma experdyo on holli ka keridhin hani hattude;
- Kodholidhin wullitoray fi kala batte fettingol faya on ko wawata wadhe ma gollitirgol masindiyidhin tippude e ebbhore nowullitorte non ka CBG, haray nden tobbhere humitinde e no wullitorte nden yewtoyte fi mun ka mediation ko humiti e ahadidiy tawabhebhen ka yewtere e ebbhore no wullitorte ;
